I understand that the Seattle Police Athletic Association is a non-profit corporation whole and separate from the City of Seattle and the Seattle Police Department.

**YOUR MEMBERSHIP OR GUEST PRIVILEGES MAY BE TERMINATED BY THE RANGE STAFF FOR VIOLATION OF ANY OF THE FOLLOWING RULES, OR ANY ACT DEEMED UNSAFE. THE RANGES AND PROPERTY ARE MONITORED BY ACTIVE VIDEO SURVEILLANCE AT ALL TIMES AND IS RECORDED FOR REVIEW AT A LATER TIME IF NECESSARY.**

## **GENERAL MEMBERSHIP RULES:**

1. Seattle Police Athletic Association (SPAA) membership identification cards are the property of the SPAA. Members must surrender their issued SPAA membership identification card upon demand of any Range Officer.
2. Members are allowed to bring adult individuals as guests but are responsible for the actions of their guests. Children will be allowed at the discretion of the Range Officer. The child must be under constant direct supervision. Eye and ear protection of appropriate size is required for the child when at the ranges.
3. Members and guests will meet at the office for sign-in, in person. Every member and their guest must be legibly signed in on the appropriate range list, PRIOR to going onto the ranges. All guests will depart the facility with the sponsoring member. A maximum of two guests are allowed with the member at any one time.
4. During sign-in, guests shall complete a Guest Agreement Waiver Form. These forms must be filled out completely and guest fees collected PRIOR to accompanying the sponsoring member out to the ranges.
5. Members are forbidden to loan their membership card to any other individual.
6. Members and guests are required to wear their membership or guest ID card visibly at all times.
7. Absolutely NO "Show & Tell" of ANY personal weapons in the SPAA office, in the parking lot, or anywhere other than on the ranges with the weapons pointed in a safe down-range direction.
8. The use of SPAA ranges for commercial purposes is PROHIBITED.
9. Alcoholic beverages are PROHIBITED on the ranges and illegal drugs are PROHIBITED on the property. Individuals who appear to be under the influence of any substance that impairs their ability to function in a safe, responsible manner will not be allowed at the facility.
10. Eating food and/or smoking is PROHIBITED on the ranges.
11. Non-alcoholic beverages are allowed on the ranges; however they must be covered, and are NOT allowed on the actual firing line.
12. The speed limit is 10 miles per hour on the entire SPAA property.
13. No gun sales are started after 4:00 pm and the CEASE-FIRE TIME is 4:30 pm.
14. THE RANGE OFFICE DECISION IS FINAL. Your guest's violation is your violation.
15. If you are unsure about violating a range rule, ASK BEFORE YOU ACT.
16. All rules are subject to modification at the discretion of the SPAA Range Staff for safety.
17. The SPAA reserves the right to deny or terminate memberships for any reason.
18. The SPAA reserves the right to refuse service to anyone and to inspect all firearms, ammunition and equipment brought to the facility.
19. All members shall check for and be aware of any additional Range and Safety rules and regulations that are also published and posted applying to other specific ranges.

## GENERAL RANGE SAFETY RULES:

1. Every individual on the range is to obey the 4 Cardinal Rules of Firearm Safety.
  - a. Treat every gun as if it is loaded
  - b. Point the muzzle in a safe direction
  - c. Keep your finger off the trigger and outside the trigger guard until you are pointed at the target and preparing to fire
  - d. Be aware of your target and what is beyond it
2. Every individual on the range is required bring and wear appropriate eye protection at all times, and ear protection when near live-fire activity. There are no exceptions.
3. Firearms shall be transported on the property in a gun box, gun case, holster, or with the action open and muzzle pointed toward the ground.
4. Firearms will only be removed from or placed in transportation cases at the firing line benches. Firearms shall be pointed down range at all times while out of the transportation case.
5. No portable stands are allowed on any range. No shooting on any range in distances closer or further than the established target holders.
6. Shooters will fire at approved paper targets only, which must be attached to the SUPPLIED TARGET FRAMES. Targets may only be attached to the backers with TAPE or self-sticking and not staples. Shooters will only shoot at targets in a path directly in front of and down-range of them. NO CROSS-LANE FIRING.
7. Shooters are to fire only from designated firing points, on the firing line within the red zone.
8. Load/Chamber/Unload firearms ONLY when on the firing line and in the RED ZONE at the bench and when there are no individuals down-range of you. Muzzles must be pointed down-range.
9. NO RAPID FIRE. All shots must be aimed. Shooters will allow about 2 seconds between shots.
10. The use of armor piercing, explosive, incendiary or tracer ammunition is PROHIBITED.
11. Black powder shooting is allowed on the ranges with the understanding that ALL containers of black powder are to be CLOSED while shooting, to prevent the possibility of a flash explosion.
12. Cease-Fire is by mutual consent. Obtain everyone's permission before turning on the alarm signal system at one of the provided locations. Best practices indicate that multiple switches should be activated for safe and effective communication between shooters.
13. During Cease-Fire breaks, all guns will be unloaded; the action opened and placed facing down-range on the bench with a chamber flag inserted. The alarm signal system shall be activated, and everyone must remain outside of the painted red zone prior to and during anyone moving forward of the shooting positions. Only when the last person has returned from down range shall the alarm signal system be deactivated.
14. Any misfired/misdirected rounds fired that do not impact the designated impact area must be immediately reported to the range office.
15. Upon completion of shooting, shooters must return the target backer to the storage area and clean up their firing points. This includes sweeping up of spent casings and disposal of such in the appropriate SPAA provided containers (Brass Buckets) and NOT in the garbage cans. Live ammunition for disposal shall be deposited in the appropriate, labeled containers on the range.
16. The removal of any spent casings from any range by an individual who did not specifically bring those casings is PROHIBITED.

## **THE FOLLOWING RULES APPLY TO THE PISTOL RANGE, IN ADDITION TO THE GENERAL RULES LISTED ABOVE:**

1. Only handguns will be fired on the pistol range.
2. Members shall note that ONLY ONE TARGET PER STAND ARE ALLOWED TO BE ATTACHED IN THE CENTER OF THE BACKER and not attached near the sides.
3. Exceptions to Rule 1
  - a. Rifles in the following calibers may be fired on the pistol range: 22LR, 9mm, 38 Spl, 357 Mag, 44 Spl, 44 Mag, 45 ACP and 45 Long Colt.
  - b. Pistols in rifle calibers shall only be fired on the rifle range.
  - c. 5.7 pistols shall only be fired on the pistol range.
  - d. 5.7 rifles shall only be fired on the rifle range.
  - e. 17HMR pistols shall only be fired on the pistol range.
  - f. 17HMR rifles shall only be fired on the rifle range.
  - g. The SPAA Range Staff shall address any other specific firearms issues.
4. Holster work (drawing a holstered handgun) is prohibited on the civilian pistol range. The pistol range is a slow-fire Bullseye format range.

## **THE FOLLOWING RULES APPLY TO THE RIFLE RANGE, IN ADDITION TO THE GENERAL RULES LISTED ABOVE:**

1. Only rifles will be fired on the rifle range.
2. Exception to Rule 1:
  - a. Thompson Contender and AR-15 pistols in rifle calibers shall only be fired on the rifle range.
  - b. Shotguns firing SLUGS ONLY can be fired on the rifle range.
  - c. The SPAA Range Staff shall address any other specific firearms issues.
3. Multiple paper targets are permitted on the backers on the rifle range. Members are requested to use caution to minimize damage created to the target holders on the outer edges due to rounds missing the actual intended target center.
4. Load/Chamber/Unload firearms ONLY when on the firing line in the RED ZONE at the bench and when there are no individuals down-range of you. Muzzles must be pointed down-range. NO LOADED RIFLES BEHIND THE RED ZONE.
5. Individuals who have permission to, and who are firing from pre-approved slots, in any position (kneeling, sitting, prone) other than from the visible, seated bench, shall place a traffic cone on top of the bench in order to alert other range participants of their status. Traffic cones will be provided by the SPAA and will be stored on the benches behind the firing line.
6. Shooters who have targets at the 200-yard line may proceed to the target area via the proper route outside the 100-yard range when they wish without using the safety warning system.

**Each member, guest, competitor, and law enforcement officer is responsible for reading all published and posted signs, and obeying all Range rules and regulations. If you observe any violation of these rules, please call a cease-fire and bring the violation to the attention of the violator or the range staff immediately. Range safety is everyone's concern.**

## **Seattle Police Athletic Association Privacy Policy**

Federal law requires that once a year we inform you of our privacy policy. While you have probably received similar notices from banks, brokers, credit card companies, etc., we are going to explain our policy in very simple, easy to understand English. This privacy policy is provided to you upon your annual SPAA renewal.

The Seattle Police Athletic Association (SPAA) collects certain personal information about you in order to complete a background check and complete the application process. This is done to ensure the safety and security of our members, the general public, and the Association. The information is provided by you or obtained by the SPAA with your permission. We do not disclose any non-public information about you to anyone, except as permitted by law or with your permission. Access to your file and personal information is restricted to those SPAA employees who have a need to know. We maintain strict physical, electronic, and procedural safeguards to protect your personal information.

The most important part of being a member of our range is SAFETY. SAFETY is not just the job of the Range Staff, but also EVERY MEMBER AND THEIR GUEST.

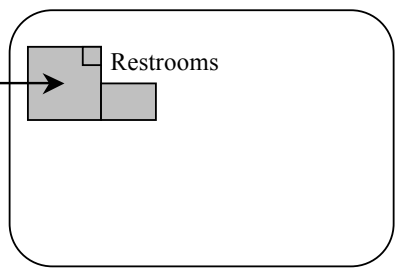
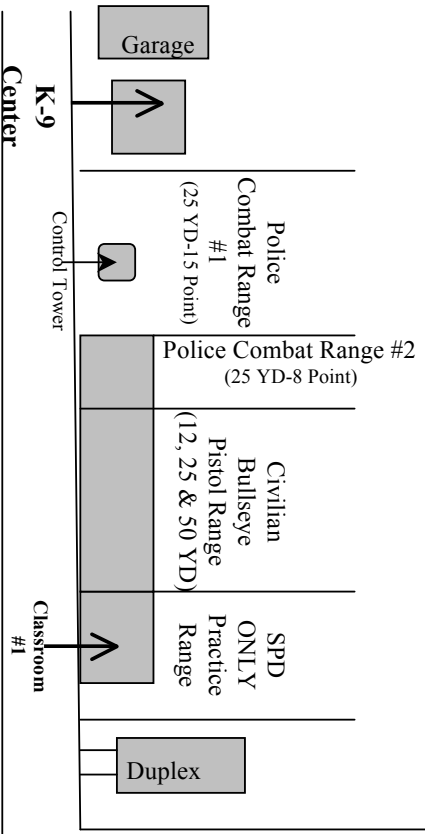
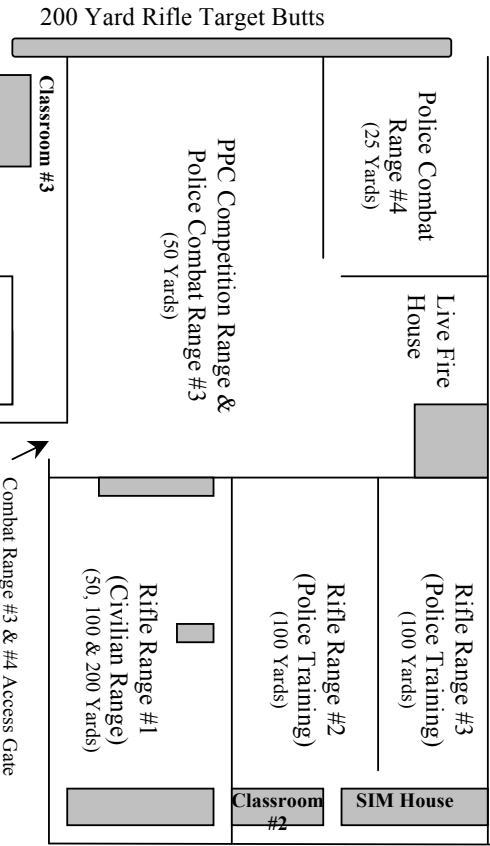
New members will be required to attend an orientation class to become familiar with Range rules, regulations, and procedures prior to range use. Scheduling information can be obtained in the SPAA office.
